EXTENDED DATE TO THE NATIONAL CACFP WAIVERS

Please be advised that the end date to the National CACFP waivers for Meal Pattern Requirement, Flexible Times and Grab & Go Meals has been extended to **August 31, 2020**.

URGENT MESSAGE IF YOU HAVE SCHOOL AGE CHILDREN

Recent provider meal claims indicate that many providers have not been reporting their school age children as out of school. Please be advised, the meal claim software (Minute Menu) will not give providers credit for the meals where the child is usually attending school. For the month of May, ECCI will be granting credit to providers that did not report the school out days. However, please be advised that for future claims, it is the providers responsibility to report the children as out of out in order to receive credit. If we gave you credit for this error, it will appear under ERROR CODE 999 on your Claim Summary and Error Report.

Providers claiming on scannable forms: Make sure you report that the children are not attending school in your Claim Information Form (CIF) under the designated area in the bottom of front page. You may also report this information in the back of the CIF. Please ensure to report the child's ID number, reason why not attending school and the dates that the child did not attend school. The Claim Summary and Error Reports get mailed to providers who claim on scannable forms.
