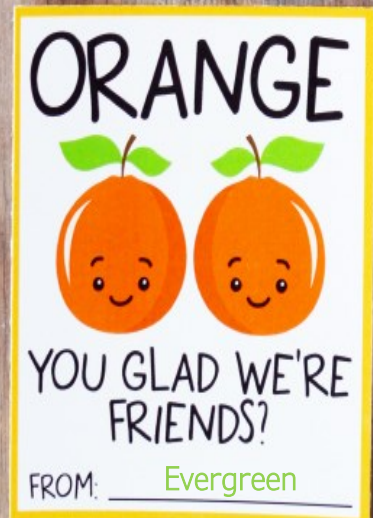
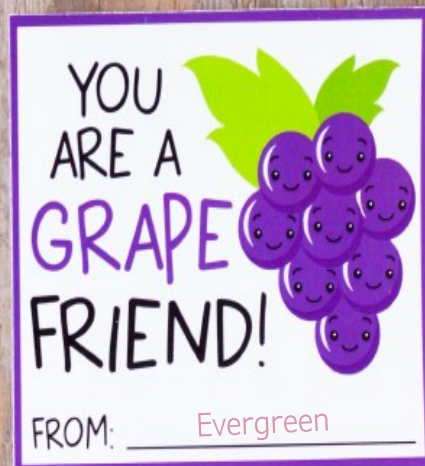

# Grant Opportunity Reopens on 02/02/21: California Relief Grant Program

California's COVID Relief Grants for small businesses will reopen for applications today, Tuesday February 2nd. It will close **Monday February 8th**.

These are small grants of between \$2,000 and \$25,000 that you are eligible for, whether you are a child care nonprofit or for profit business.

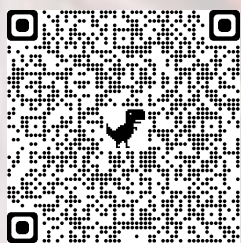
