UPDATED FORMS

TAX REPORT

It's that time again! Tax season is upon us. Here are instructions on obtaining your 2021 Tax report:

Meal Benefit Form (MBF): As a reminder, we have updated the MBF, used to determine eligibility for the provider's own children or foster care. Please keep in mind, any current enrolled children do NOT need this updated form at the moment. Moving forward, any of the provider's own children or foster children who will be enrolled in the daycare must use the updated MBF. All MBF are updated annually in the month of August. Below is the direct link and is also located in our website under the FORMS tab.

For providers claiming on KidKare: Under REPORTS>select a category> CLAIM STATEMENTS>select a report>TAX REPORT>select a year> 2021>then click RUN

Milk Substitution Form: As a reminder, we have updated the milk substitution form. This form is for any child who does not have a disability, but the legal guardian is requesting a fluid milk substitute due to a medical or other special dietary need. Please understand, this form is not intended to accommodate children who want a milk substitution due to taste preference.
