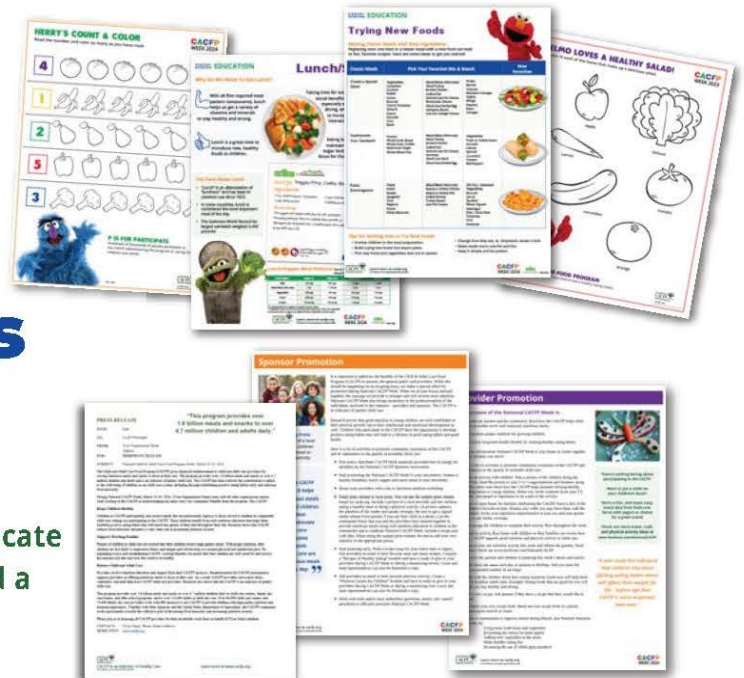
National CACFP Week

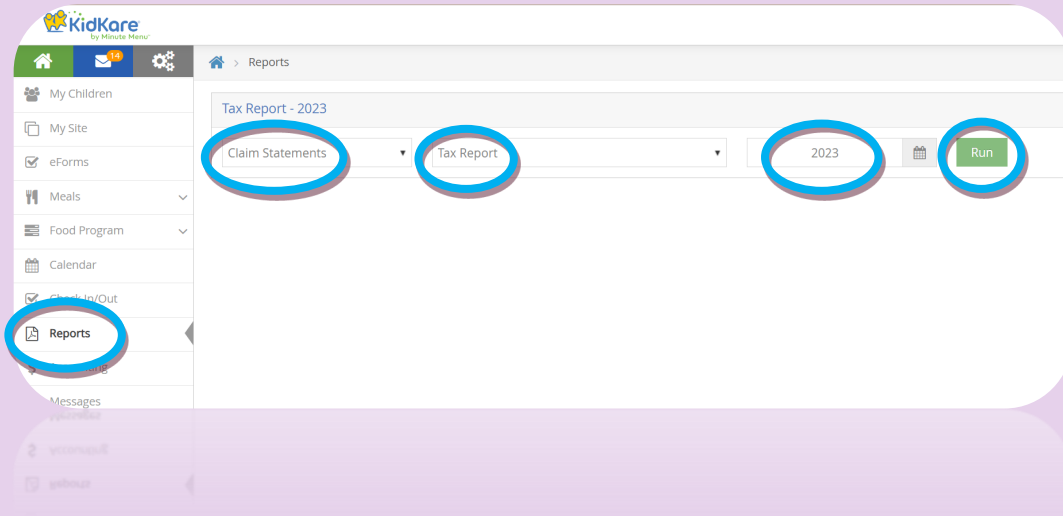

It's that time again! Tax season is upon us. Here are instructions on obtaining your 2023 Tax report:

Click on **REPORTS** on the side toolbar> select a category> CLAIM STATEMENTS>select a report>TAX REPORT>select a year> 2023>then click RUN



Claim Summary & Error Report

Ensure to review your Claim Summary Report after submitting your claim. This report will show you the reimbursement amount you will be receiving and will inform you of any errors found in your meal claim. If you need assistance with the report, please contact us. Please be advised, it is the provider's responsibility to review their Claim Summary and Error Report.
